Based on filings with the U.S. Securities and Exchange Commission for the period ended June 30th, 2020 the following owners of 5% or more of S&P Global Inc. stock also owned 5% or more of a publicly traded entity known to be or to own an EU-registered Credit Rating Agency:

- The Vanguard Group, Inc., which held 7.46% of Moody's Corporation
- BlackRock, Inc., which held 5.8% of Moody's Corporation
